**7. OPEN FORUM**

The Chairman asked for questions to be taken at this point:

**a. Mr Euan Duncan, Reporter for the Biggleswade Chronicle**

Mr Duncan asked what the replacement will be for the planned changes to Century House on the Market Square.

Cllr G Fage advised that the Council believes Century House is not the best use of space on the Market Square. Other matters on which the planned changes may depend, such as location of public toilets and bus routes, are being considered in conjunction with Central Bedfordshire Council. Earmarked S106 monies for the Town Centre will be used to create new landscaping, soft seating spaces and a more modern town centre.

The Town Clerk & Chief Executive added that the Town Council has been working closely with Central Bedfordshire Council in planning the future of the Market Square. Central Bedfordshire Council has commissioned an independent review to put forward ideas for consideration and the Town Council looks forward to receiving that report to examine what commercial opportunities might be presented.
