Cllr M North informed members of his attendance at the Potton Civic Service on 14th October 2018. Cllr M North also viewed the Biggleswade History Society Archive on the 23rd October 2018 which had all the documentation of those from Biggleswade who fought in World War 1.

Cllr M North read out a message from Cllr M Russell in her absence. Members were pleased to learn that following the successful visit of Biggleswade Choral Society to Erlensee in 2013, a male voice choir, The Sound Brothers, paid a return visit this weekend (20th – 21st October 2018). Chamber Choir joined The Sound Brothers for a joint concert at a packed St Andrews Church on Saturday evening and The

Sounds Brothers sang at the Eucharist service at St Andrews on Sunday morning. Members were pleased to hear of another successful link with our Twin Town Erlensee.

4. PUBLIC OPEN SESSION

Dr Hayley Whitaker commented on Item 13 Correspondence – Rt Hon Alistair Burt MP.

Dr Whitaker, a commuter from Eyeworth, wished to know of where she should park her car when the Biggleswade Station car park is full. Currently, the policies in Biggleswade Town Council car parks do not allow long-stay parking for those commuting from Biggleswade Station. It was noted that Dan Albone offers 9 hours of parking, however this is a longer walk from the station and so does not provide a solution to those who cannot walk for long distances and in many cases still does not provide enough time for those who are commuting. Dr Whitaker explained that many commuters are now parking on residential streets who would happily pay to park in BTC car parks.

Dr Whitaker explained that she had previously emailed Biggleswade Town Council who responded that it is Network Rail's/Great Northern's responsibility to provide adequate parking for commuters. When contacted, Network Rail and Great Northern responded that it is Biggleswade Town Council's responsibility.

Dr Whitaker wished for a decision to be made sooner than January 2019. It was suggested that a good compromise for parking in the meantime would be to make one of the BTC car parks commuter parking.

Members raised the following comments:

The new Parking Order was partly put in place to resolve the lack of spaces in Rose Lane Car Park for Rose Lane Residents and those visiting the Town Centre. The restrictions would enable us to gauge the numbers of commuter cars parking in Biggleswade Town Centre car parks. Since the Parking Order has been implemented we have noted that there is spare capacity and need for commuters to use the BTC car parks.

It was noted that there is a high turnover on the BTC car parks so there are a greater number of cars that park there than it appears.

It was noted that we have previously tried to acquire land for additional commuter parking however for several reasons we were unable to do so.

It was **RESOLVED** that the Town Clerk responds to Alistair Burt explaining that Biggleswade Town Council are conscious of the challenges faced with parking in Biggleswade and that we are currently working on putting together a proposal that works for residents, commuters and visitors.

Dr Hayley Whitaker commented further on Item 11e Correspondence – Rt Hon Alistair Burt MP.

Dr Whitaker explained that Biggleswade Station is the closest train

station for many surrounding villages and those who park in Biggleswade to commute spend money in Biggleswade as a result.

Dr Whitaker raised concerns on the safety of commuters who will now be walking a further and more isolated distance in the dark to their cars. Dr Whitaker wished for there to be a temporary solution put in place and was disappointed that this had been deferred for discussion at a future meeting.

Dr Whitaker explained that she will conduct a survey through the Railway Users Group to gather data on where commuters live and report the findings back to BTC.

Mr Bacon suggested that we need to build a multi-storey car park in Biggleswade to cater for the numbers of commuters. It was explained that this option has already been looked into and is not financially viable.

Mr Bacon informed members that two street lights near the bus station are not currently working. Members responded that this is the responsibility of Central Bedfordshire Council.

It was **RESOLVED** to hold a Working Group to review the information currently available. The following members wished to attend the Working Group: Cllr M Foster, Cllr D Albone, Cllr I Bond, Cllr B Briars, Cllr G Fage, Cllr F Foster, Cllr M North, Cllr P Sheldon. It is intended for a further meeting of the working group once 6 months data has been collected and to report back to Town Centre Management Committee with any recommendations.

b. Commuter Parking

Members considered correspondence from Alistair Burt MP and a rail user regarding commuter parking.

It was **RECOMMENDED** that we reply to Alistair Burt, thanking him for his letter and explaining that a review of car parks will be carried out after 6 months operation. Also that alternative options continue to be explored however the rail operators could do more to support commuters. Also to note that any changes to usage of Rose Lane car park would only be a short term solution due to the length of the current lease.

It was **RECOMMENDED** to reply to correspondence from the Potton resident, noting the concerns and advising that car park usage would be reviewed after 6 months operation.

c. White Hart Car Park

Members considered a request from Greene King to change the name of the White Hart Car Park.

It was **RESOLVED** to respond to Greene King that the car park has been known as the White Hart Car Park for many years and it is not intended to change the name or the signage.

Flags at the town centre war memorial

On 4 August 1914, Britain declared war on Germany. She committed herself to fight in the defence of certain principles which have defined British foreign policy since the 19th Century; the principle of national sovereignty, which was defiled by the German Army as it marched through neutral Belgium, and the principle that aggressors – whether their aggression be territorial or moral in nature – cannot be allowed to act unimpeded whilst the freedom loving nations of the world stand idly by and do nothing. Britain stood in the spirit of the words of Edmund Burke: 'all that is necessary for the triumph of evil is that good men do nothing.' Almost nine million soldiers from the United Kingdom and the British Empire laid down their lives in the defence of freedom, sovereignty and justice, in the face of a militant and tyrannical regime. They fought for the freedom of Europe and its people. On 11th November, the day upon which, in 1918, the guns fell silent, we will remember them.

In the following years, the United Kingdom fought twice for freedom and liberty in eastern Europe – successfully contributing to the defence of Estonia and Latvia against the murderous, inhuman ideology of bolshevism to which Russia had fallen.

In 1939, Britain again went to war in the defence of national sovereignty and in the face of an aggressive, militaristic aggressor. This time it was Nazi Germany's invasion of Poland which sparked British intervention on the continent, and for nearly two years following the fall of France, Britain and her allies in the Commonwealth stood alone in the world against the fascist menace. The death toll reached almost 70 million as all the world was plunged into darkness. On 11th November, we will remember them.

British soldiers would again fight against communism in Greece, Malaya and Korea, and against a fascist junta which sought to establish rule over British citizens in the Falkland Islands in 1982. The United Kingdom fought against Saddam Hussein's Iraq for the freedom of Kuwait, against the slaughterers of Kosovar refugees, and against the perpetrators of war crimes and crimes against humanity in Sierra Leone. In partnership with the international community, and the foremost of our allies – the United States – our brave servicemen and women fought against despots and terrorists in Afghanistan and Iraq, and British forces remain engaged from the air in the war against Daesh: a death-worshipping cult of barbarians which is responsible for the persecution of religious and minority groups, the vile treatment of civilians, the use of child soldiers, sexual violence and slavery, beheadings, mass executions and the use of chemical weapons.

Over more than a century, Britain has fought consistently to uphold the values of democracy, individual liberty, justice and the rule of law. We have fought against fascism, communism and the

whole range of depravity that lies between, in the extreme corners of political and theological thought. The price that our people have paid in the maintenance of international law, of global security and of the cause of lasting peace, has been enormous: the sacrifices made by our soldiers unparalleled. It is right that on 11th November, Biggleswade – which has herself committed hundreds of warriors to the British Armed Forces since 1914 – will come together at the town centre war memorial to commemorate the fallen; those who have been martyred under our flag of red, white and blue, and who have given their lives under the banner of all that is right and good about humanity. It is right that on 11th November, we will remember them.

But I worry that these men and women, who are the heroes of our town, our nation and our world, are not sufficiently remembered and commemorated throughout the remainder of the days which pass by each year. It dismays me to see that, as I pass the war memorial in the centre of the market square, it frequently stands with flagpoles erect but un-arousing – with the flag of the United Kingdom absent, and the flag of our town absent too.


Occasionally, of course, both flags appear. And, presumably at a not inconsiderable cost to the local taxpayer, a person is employed to raise the flags in aid of a specific event or date, and lower them again when the moment of glory has passed.

To appeal to your pecuniary prowess, I would put it to you that it would be cheaper and more effective to leave the flag of the United Kingdom and the flag of Biggleswade flying above the memorial on a constant, permanent basis throughout the year – flying as does the flag above the Stratton House Hotel, and depicting the pride and affection which we feel for those who have marched under that banner as do the flags which stand constantly beside the Cenotaph in Westminster. To appeal to your heart, I would put it to you that Biggleswade should be proud of her place in Britain – and proud of Britain's place in the world. The flags of our town and of our nation should fly all year round, in each and every day: creating a proud focal point for our community, a clear expression of our civic and national identity.

I feel certain that the many local people who, throughout history, have given their lives in the defence of the things they loved and valued, would want to see these flags flying proudly throughout the year. When they went off to fight, they did so ultimately in the defence of their fellow townsmen and women; their fellow Biggleswadians and their fellow Britons. They fought for the future of all of us, and they did so, I am sure, in the certainty that we in the future would be proud of them and proud of ourselves.

So, I say let the flags fly: when you raise the Union Flag and the town flag above the war memorial for Remembrance Sunday, let them remain there and raised for the weeks, months and years to come. Let them remain as beacons of our identity and our pride. Let them fly evermore.

3. Lawrence Road, north side, from its junction with Auckland Road extending in a south-easterly direction to a point approximately 2 metres south-west of a point in line with the boundary of nos.82 and 84 Lawrence Road.
4. Lawrence Road, south side, from a point approximately 3 metres north-west of a point in line with the boundary of nos.80 and 82 Lawrence Road extending in a south-easterly direction to a point approximately 2 metres south-east of a point in line with nos.82 and 84 Lawrence Road.
5. Auckland Road, both sides, from its junction with Lawrence Road extending in a northerly direction for approximately 18 metres to a point in line with the boundary of nos.2 and 4 Auckland Road.
6. Auckland Road (east spur access road), both sides, from its junction with Auckland Road extending in a north-easterly direction for approximately 5 metres.
7. Lawnside, east side, from its junction with Lawrence Road extending in southerly direction to a point approximately 2 metres north of the north flank wall of no.80 Lawrence Road.

This Order shall come into operation on xxth day of (Month) 201* and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.*) Order 201**"

2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

To add No Waiting at any time on the following lengths of road in Biggleswade:-

- (i) Lawrence Road, south side, from a point approximately 1 metres south-west of a point in line with the boundary of nos.77 and 79 Lawrence Road extending in a north-easterly direction to a point in line with the west flank wall of no.87 Lawrence Road.
- (ii) Lawrence Road, south side, from a point approximately 1 metre south-west of a point in line with the boundary of nos.77 and 79 Lawrence Road extending in a north-easterly direction to its junction with Auckland Road.
- (iii) Lawrence Road, north side, from its junction with Auckland Road extending in a south-easterly direction to a point approximately 2 metres south-west of a point in line with the boundary of nos.82 and 84 Lawrence Road.
- (iv) Lawrence Road, south side, from a point approximately 3 metres north-west of a point in line with the boundary of nos.80 and 82 Lawrence Road extending in a south-easterly direction to a point approximately 2 metres south-east of a point in line with nos.82 and 84 Lawrence Road.
- (v) Auckland Road, both sides, from its junction with Lawrence Road extending in a northerly direction for approximately 18 metres to a point in line with the boundary of nos.2 and 4 Auckland Road.
- (vi) Auckland Road (east spur access road), both sides, from its junction with Auckland Road extending in a north-easterly direction for approximately 5 metres.
- (vii) Lawnside, east side, from its junction with Lawrence Road extending in southerly direction to a point approximately 2 metres north of the north flank wall of no.80 Lawrence Road.

Flags at the town centre war memorial

On 4 August 1914, Britain declared war on Germany. She committed herself to fight in the defence of certain principles which have defined British foreign policy since the 19th Century; the principle of national sovereignty, which was defiled by the German Army as it marched through neutral Belgium, and the principle that aggressors – whether their aggression be territorial or moral in nature – cannot be allowed to act unimpeded whilst the freedom loving nations of the world stand idly by and do nothing. Britain stood in the spirit of the words of Edmund Burke: 'all that is necessary for the triumph of evil is that good men do nothing.' Almost nine million soldiers from the United Kingdom and the British Empire laid down their lives in the defence of freedom, sovereignty and justice, in the face of a militant and tyrannical regime. They fought for the freedom of Europe and its people. On 11th November, the day upon which, in 1918, the guns fell silent, we will remember them.

In the following years, the United Kingdom fought twice for freedom and liberty in eastern Europe – successfully contributing to the defence of Estonia and Latvia against the murderous, inhuman ideology of bolshevism to which Russia had fallen.

In 1939, Britain again went to war in the defence of national sovereignty and in the face of an aggressive, militaristic aggressor. This time it was Nazi Germany's invasion of Poland which sparked British intervention on the continent, and for nearly two years following the fall of France, Britain and her allies in the Commonwealth stood alone in the world against the fascist menace. The death toll reached almost 70 million as all the world was plunged into darkness. On 11th November, we will remember them.

British soldiers would again fight against communism in Greece, Malaya and Korea, and against a fascist junta which sought to establish rule over British citizens in the Falkland Islands in 1982. The United Kingdom fought against Saddam Hussein's Iraq for the freedom of Kuwait, against the slaughterers of Kosovar refugees, and against the perpetrators of war crimes and crimes against humanity in Sierra Leone. In partnership with the international community, and the foremost of our allies – the United States – our brave servicemen and women fought against despots and terrorists in Afghanistan and Iraq, and British forces remain engaged from the air in the war against Daesh: a death-worshipping cult of barbarians which is responsible for the persecution of religious and minority groups, the vile treatment of civilians, the use of child soldiers, sexual violence and slavery, beheadings, mass executions and the use of chemical weapons.

Over more than a century, Britain has fought consistently to uphold the values of democracy, individual liberty, justice and the rule of law. We have fought against fascism, communism and the

whole range of depravity that lies between, in the extreme corners of political and theological thought. The price that our people have paid in the maintenance of international law, of global security and of the cause of lasting peace, has been enormous: the sacrifices made by our soldiers unparalleled. It is right that on 11th November, Biggleswade – which has herself committed hundreds of warriors to the British Armed Forces since 1914 – will come together at the town centre war memorial to commemorate the fallen; those who have been martyred under our flag of red, white and blue, and who have given their lives under the banner of all that is right and good about humanity. It is right that on 11th November, we will remember them.

But I worry that these men and women, who are the heroes of our town, our nation and our world, are not sufficiently remembered and commemorated throughout the remainder of the days which pass by each year. It dismays me to see that, as I pass the war memorial in the centre of the market square, it frequently stands with flagpoles erect but un-arousing – with the flag of the United Kingdom absent, and the flag of our town absent too.

Occasionally, of course, both flags appear. And, presumably at a not inconsiderable cost to the local taxpayer, a person is employed to raise the flags in aid of a specific event or date, and lower them again when the moment of glory has passed.

To appeal to your pecuniary prowess, I would put it to you that it would be cheaper and more effective to leave the flag of the United Kingdom and the flag of Biggleswade flying above the memorial on a constant, permanent basis throughout the year – flying as does the flag above the Stratton House Hotel, and depicting the pride and affection which we feel for those who have marched under that banner as do the flags which stand constantly beside the Cenotaph in Westminster. To appeal to your heart, I would put it to you that Biggleswade should be proud of her place in Britain – and proud of Britain's place in the world. The flags of our town and of our nation should fly all year round, in each and every day: creating a proud focal point for our community, a clear expression of our civic and national identity.

I feel certain that the many local people who, throughout history, have given their lives in the defence of the things they loved and valued, would want to see these flags flying proudly throughout the year. When they went off to fight, they did so ultimately in the defence of their fellow townsmen and women; their fellow Biggleswadians and their fellow Britons. They fought for the future of all of us, and they did so, I am sure, in the certainty that we in the future would be proud of them and proud of ourselves.

So, I say let the flags fly: when you raise the Union Flag and the town flag above the war memorial for Remembrance Sunday, let them remain there and raised for the weeks, months and years to come. Let them remain as beacons of our identity and our pride. Let them fly evermore.
