To receive an update from PC Bonham 5725 on theft from motor vehicles.

For all Council members to be aware of the increase in theft from motor vehicles in BIGGLESWADE over the last three weeks. The incidents have primarily happened in the Stratton area around Buttercup Mead, Ribble Mead, Tansey End and Sorrel Way, however other areas have been affected.

We have sent out Beds alert and Twitter messages and officers have visited most of the victims, however increased vigilance by the community would help to reduce further incidents.

Leaflet drops offering crime prevention and safeguarding advice have also been handed out in the area.

If any residents have reported to you but not the police, please encourage them to call 101 or report online so that we have a true picture of the issues.

- B28/0806.1 a. Cllr B Briars: Have we received an update on the status of the double yellow lines Sun Street, Lawrence Road etc. We have now been promised three times that this work will happen by the end of the month. This is an unacceptable situation.

The Town Clerk reported that delays and lack of response had occurred due to annual leave of CBC officers. However, this is now an Agenda item on the Biggleswade Joint Committee meeting on 6 September.

Cllr Watkins confirmed that CBC Highways have visited the area. A review has been promised and he will continue to liaise with Mr Bacon when he is in receipt of the information.

- B28/0808.2 b. It was requested that the Schedule of Planning Outcomes be reviewed as it was felt that some of the information was out of date.

There will also be an update on East/West Rail. Cllr M North, and Cllr M Foster are attending Cllr Bond will confirm in one week.

B28/0811.2 b. **Correspondence – Parking**

i. **Letter from Corey Albone**

Members requested that the Town Clerk send a response to Mr Albone confirming that the Biggleswade Town Council upheld their obligation to consultation, even extending the time of the consultation for longer than necessary. The policy was changed in light of the consultation. If there is any evidence of Councillors being openly dismissive, then Mr Albone needs to bring this forward.

The Council will be keeping this under review on a regular basis

ii. **Letter from Tony Stead**

Members welcomed the positive comments regarding the new controlled parking in Biggleswade.

However, the question raised of inconsiderate parking in the evenings would need to be addressed by the police. The yellow lines at the Bingo Hall are 8am to 6pm daily. There is therefore no restriction for parking in the evenings.

Members requested that the Town Clerk write to the police and inform them of the hazards pointed out by Mr Stead, and asking for a review of the evening parking in the town, particularly on pavements and roundabouts.

B28/0812.1 **a. Planning Application Outcomes**

Members asked for clarification from CBC regarding permission being granted for 15 Market Square concerning internal illumination despite this being a conservation area.

There was also concern that the Application for Land at Bonds Lane and Foundry Lane is still awaiting decision.

Concern was noted that Council have not seen amendments to the Application for Wilsheres Road, that has now been resubmitted and granted.

Members asked for the status of the Drove Road Application. The Town Clerk has not been able to obtain satisfactory information from either the CBC Officer, or the Architect. Members asked that Cllr Watkins take this up with CBC as a matter of urgency.

This agreement to book the venue is made between Biggleswade Town Council (hereafter known as 'Council') and the Hirer. Please read and sign.

Your signature also confirms that you have read and understood the conditions of booking and that you agree to the hiring charges.

STANDARD CONDITIONS OF HIRE
ORCHARD HALL/ORCHARD TRAINING ROOM

For the purpose of these conditions, the term HIRER shall mean an individual hirer or, where the hirer is an organisation, the authorised representative.

1. The **HIRER** will, during the period of hiring, **be responsible** for the supervision of the premises, fabric and the contents, their care, safety from damage, however slight, or change of any sort and the behaviour of all persons using the premises, whatever their capacity, including proper supervision of car parking arrangement so as to avoid obstruction or inconvenience to other persons.
2. The **HIRER** shall not sub-hire or use the premises for any other purpose other than that described in the booking form and **shall not hire** or use the premises for any unlawful purpose or in any unlawful way nor do anything or bring onto the premises anything which may endanger the same or any insurance policies in respect thereof **nor allow the consumption of alcoholic liquor thereon without written permission and the**
3. The **HIRER** shall be responsible for **obtaining any licences** that may be needed for the **sale and consumption of alcoholic liquor, for music (PPL and/or PRS)** and for the observance of the same and all other regulations appertaining to the premises stipulated by the Fire Authority and the Local Magistrates Court, or otherwise.
4. The **HIRER shall indemnify the Council for the cost of repair of any damage** done to any part of the property that may occur during the period of the hiring as a result of the hiring **up to a maximum of £125**, this being the current insurance excess relating to the Council's property. The **HIRER** shall also be responsible for making arrangements to insure against any third-party claims which may be made against them (or the organisation if acting as a representative) whilst using the premises.
5. The **HIRER** will, during the period of hiring, be responsible for ensuring no glassware, cans, or other receptacle is taken from the interior of the premises for whatever purpose. This also includes furniture and equipment provided at the premises.
6. The **HIRER** is responsible for ensuring that any electrical appliances or equipment brought into the premises is fully compliant with current Safety Regulations. A call-out charge may be levied by the Council in the event that the electrical supply has to be reset. Where a residual circuit breaker is provided the **HIRER** must make use of it in the interest of public safety.
7. The **HIRER** must not use any cooking equipment outside the premises as this constitutes breach of health and safety regulations and environmental issues.
8. It is the responsibility of the **HIRER** to familiarise themselves with the location of fire exits and the fire extinguishers and how to use them. If the fire cannot be extinguished safely and immediately, the fire alarm must be activated and the building evacuated by the nearest, safest, exit. If time allows, all electrical supplies should be switched off and doors and windows shut. **Telephone the emergency services.**
9. **Ball Games** including the throwing of soft balls, frisbees, and other projectiles are strictly forbidden inside the premises.
10. The use of **Bouncy Castles and other inflatables** is not permitted without prior, written, permission.

11. At the end of the hiring (all functions to have ceased by 11.55 pm with premises fully vacated by Midnight) the premises must be left **in a clean and tidy condition**, otherwise the Council will make an additional charge. **Music must cease by 11:30 pm.**
12. If the **HIRER** wishes to cancel the booking before the date of the event and the Council is unable to procure a replacement booking, repayment of the hire fee is at the discretion of the Council.
13. In the event that any part of the premises is rendered unfit by reasons beyond the control of the Council for the use for which it has been hired, the **COUNCIL** shall not be liable to the **HIRER** for any resulting loss or damage.
14. The **COUNCIL** shall not be liable to the **HIRER** for any loss or damage sustained by the **HIRER** as a result of any failure or delay on the part of the Council in the performance of any of its obligations under this agreement to the extent that such failure or delay is beyond the reasonable control of the Council, including but not limited to Acts of God, Labour disputes, Transportation failure, riots or civil disturbance.
15. The **COUNCIL** reserves the right to vary the Conditions of Hire applicable to this contract, including but not limited to variations in the premises, the period of hire, the rate of charge and the calculation of charges, on giving written notice to the **HIRER**.
16. The **HIRER** shall ensure that nothing is done during the period of hire in contravention of the law relating to gaming, betting and lotteries.
17. The **HIRER** shall, if preparing, serving or selling food, observe all relevant food **HEALTH AND HYGIENE** legislation and regulations.
18. The **HIRER** must report all accidents involving injury to the public to the Council as soon as possible. Any failure of equipment belonging to the Council must also be reported as soon as possible. Certain types of accident or injury must be reported on a special form to the Local Authority. The **COUNCIL** will give assistance in completing this form. This is in accordance with the Executive Reporting of Injuries, Diseases and Dangerous Occurrences Regulations 1995.
19. The **HIRER** shall ensure that any activities for children under eight years of age comply with the provisions of **the Children Act 1989** and only fit and proper persons have access to the children.
20. The **COUNCIL** reserves the right to refuse a booking without notice or to cancel or to cancel this hiring agreement at any time either before or during the term of the agreement upon giving 7 days-notice in writing to the **HIRER**. The **HIRER** shall be entitled upon such notice to reimbursement of such monies including any deposit or a proportion of the same as have been paid by the **HIRER** to the **COUNCIL**, but the **COUNCIL** shall not be liable to make any further payments to the **HIRER**.
21. No responsibility is accepted for any loss, damage or injury to any property or persons using the premises (except for any deaths or personal injury caused but the negligence of the **COUNCIL**).
22. The **HIRER** agrees with the **COUNCIL** to observe and perform the provision and stipulations contained or referred to in the Council's Standard Conditions of Hire for the time being in force as described above (an understanding of which the hirer acknowledges, together with any **special conditions** set out in the schedule below):
 - No bookings to be taken more than two years in advance
 - Hiring fee will be based on the published scale of charges which are subject to an annual review

- Fees for commercial bookings may vary and be dealt with on an individual basis
 - **All fees and charges must be paid in advance of the booking unless the HIRER has an approved credit account**
 - **Credit accounts must be settled in full by the 20th of each month following the hire date**
 - **Fees for private bookings will be paid in full at least one month before the date of hiring or in any other prescribed manner or interval that the COUNCIL chooses in the case of block bookings**
 - Noise must be kept to a minimum on arrival and departure
 - **HIRERS** cannot access the hall before the agreed time unless previously agreed with the Centre Manager
 - **HIRERS** are responsible for removing and recycling cans, glass, cardboard and plastic bottles
 - No more than 140 persons are allowed to attend any one letting in the Hall
 - No more than 34 persons are allowed to attend any one letting in the Training Room
 - An additional 10% is added to the hire charges where a **HIRER** does not have its own public liability Insurance and requests cover under the **COUNCIL'S** insurance cover
 - **A deposit of £100 will be payable for all adult functions and those which finish after 6.00 pm regardless of age, which will be paid into the council's bank account and refunded by way of a cheque after the event, provided there is no damage and the event finishes at the agreed time. In the event that the function finishes late and/or the premises are damaged in any way, then the deposit will be used in whole or in part to pay the extra time used and/or for repairs/redecoration, as necessary.**
23. **This agreement is made between Biggleswade Town Council and the HIRER whereby in consideration of the charges the Council agrees to permit the hirer to use the premises for the purpose and period shown on the booking form.**
