#### B22/1003 3. TOWN MAYOR'S ANNOUNCEMENTS.

Cllr Russell attended the following events:

#### 11<sup>th</sup> October: Presentation to CBC's Infrastructure & Development Board.

The IDB is a group of developers brought together by CBC, supported by their officers, including the Director of Regeneration, and chaired by a former senior civil servant. The focus for the meeting was development in the A1 corridor and the Mayor was invited to give the Town Council's viewpoint. Other Speakers were Jackie Sadek of UK Regeneration and Tom Leeming of Tritax Symmetry. The presentation was followed by questions and discussion.

#### 17<sup>th</sup> October: Bedfordshire Association of Town & Parish Councils' AGM:

The AGM took place at Cople Village Hall and was very well attended., including four representatives from Biggleswade – Cllrs Ramsay, Knight, Thomas and Russell. The Mayor was re-elected to the County Committee for a further four-year term.

Just before the meeting the Mayor was approached by Brickhill Parish Council who wished to put forward a motion for debate. The motion was due to be seconded by Stewartby Parish Council, but they were unable to be present. The Mayor was asked to second, and after a brief discussion with Biggleswade colleagues, agreed to do so, in order that the motion could be debated. The motion was:

"That BATPC is concerned about the effect of repeated illegal encampments on councils and local communities and the cost and disruption incurred. We ask for better legislative means to deal with encampments, to prevent them when they arise and to sanction against those who repeatedly camp in unauthorized locations, and against the damage caused".

The motion was carried by a substantial majority and the concerns will be sent to Bedfordshire unitary authorities and also to the National Association of Local Councils.

There were presentations on major infrastructure from Martin Tugwell, Programme Director, England's Economic Heartland.; Will Gallagher, Strategic Director, East West Rail, and Nicole Morris, Airspace and Noise Performance Manager, Luton Airport.

The Outline Transport Strategy for the Heartland is out for consultation until the end of the month and is available on their website. It was confirmed that an announcement on the preferred route for East West Rail is still expected before Christmas.

The presentation from Luton Airport showed that proposed new flight paths will affect Biggleswade and the surrounding area. The Mayor suggested that Nicole Morris be invited to the Town Council to give her presentation and that surrounding parishes be invited to send representatives.

To whom it may concern,

I am writing to ask if my Father, the late Rex Huckle, could be recognised by Biggleswade Town Council for the considerable work that he did for the town.

My Father was born near Biggleswade in 1916 married my Mum in 1945 whereupon I was born in 1947 and my late sister in 1952. He was a local market gardener and keen sportman, in particular football and cricket.

My parents were both in the local 'V Gang' and as keen dancers gave dancing lessons at Georges Hall, a venue where my Father would go on to be the MC and front man to performing local bands.

Being very community minded my Father helped form Biggleswade Carnival in the 1950's and became its Chairman. It was his idea to put all the profits into getting the town an open air swimming pool, despite not being a swimmer himself. This was achieved during the 60's and became a very popular meeting place in the town. Soon after its opening my Father started The Beaver Club for disabled children which I believe is still going today using the Leisure Centre Pool.

He also started a warning lights scheme for elderly people living on their own.

My Father became a Town Councillor and went on to be Mayor and along with my Mother and sister went along to The Queens Garden Party at Buckingham Palace in June 1970. I did not attend as male children were not invited! The visit to Buckingham Palace was undoubtedly one of his proudest moments. However, I think if he were here now he would say it was his work for the town and its people and the legacy he has that he was most proud of.

My Father died in 1971 and yet when old photographs were posted on We Love Biggleswade Facebook page people immediately recognised him and spoke so warmly about his work.

The family would be deeply touched if his endeavours for Biggleswade could be recognised in some way? Perhaps in a street name or a plaque at the new Splash Park if it is built. I would be very happy to discuss any suggestions you may have.

London Luton Airport Ltd

Dear Sir/Madam,

London Luton Airport Limited will be consulting, between 16 October and 16 December 2019, on proposals to expand London Luton Airport in terms of the number of passengers and flights it can handle.

To achieve this, we are proposing to make best use of the existing runway by building a new terminal, infrastructure, public transport facilities, and improvements to roads and highways. This will be classified as a Nationally Significant Infrastructure Project, and so will be decided by the National Planning Inspectorate and the Government, rather than by local planning authorities.

As part of this process, we must consult people and communities on our proposals. From October to December we will be holding 34 consultation events across the region, where people can ask the project team questions, and provide their feedback. Our consultation materials and feedback forms will also be available on our website (futureluton.llal.org.uk) and at 31 document inspection venues in libraries and council offices across the three counties region of Bedfordshire, Buckinghamshire and Hertfordshire.

In order to raise awareness about the consultation and to make sure as many people as possible use this opportunity to have their say on our proposals, we hope that you will be able to place the enclosed posters on your noticeboards or in a similar place.

Good evening Councillor Strachan and Councillor Bond,

I have been asked if I would give you both an update on the work the Local Community Policing Team have completed and that is in progress around the issues and concerns you have brought to the attention of Chief Superintendent Boyle this evening.

In response to the information you have around drugs being sold at McDonalds- my colleague PCSO Jessica Hirst has been speaking to the manager at the Biggleswade unit and he is very eager for us to hold Surgeries/ drop in sessions there. We are meeting him this weekend to discuss further and get some dates in our diaries. We can discuss the concerns around drug dealing whilst we are there and as you can imagine the presences whilst carrying out these engagements in and around McDonalds should discourage this activity. With the added benefits of working with McDonalds I am hoping there will be a noticeable difference.

As for the drug activity around the Basketball court (Eagle Farm) we can carry out patrols, engaging with the young people and try and establish who is involved and when this is happening. The input the council will be having around submitting intelligence and report will help us achieve this.

My update on Dark lane- when first reported Officers did go out and the following day, I spent several hours in Ivel Gardens speaking to residents followed by door knocking in Shortmead Street where the lane comes out, as this was on foot any offenders in the area would of seen my presences. We also spoke to a business opposite to gather as much intelligence as possible. We then continued patrols over the following weeks, looked at CCTV, put up Police Patrol Posters, so offenders are aware we are checking the Lane. Advise was given in relation to the shrubs and overgrown trees, asking if this could be looked at and at the appropriate time cut back. Since then I have had positive feedback that there is little activity there now and just this afternoon an Officer came in to our Officer stating he has been asked by a member of the public to update me that the problems in Dark Lane have stopped. Unfortunately, realistically we are unable to stop all drug dealing but I am hopeful in the area of Dark Lane it has been reduced considerably.

The last concern raised to me is the alleyway between Mead End and London Road, this is an area a few years ago I worked on, with multi-agency working including CAPs we addressed the rubbish, under-age drinking, damaged fencing and Anti-Social Behaviour from young people. This improved the location and the problems, but I am aware that this is another alleyway in Biggleswade that is potentially being used for drug dealing and is a cut through between the roads. We are now working on gathering intelligence around individuals who may be committing these offences, we can also look at patrolling the area to deter the individual.

The work around Carter Meadow will be ongoing, previously due to the increase in vehicle crime both myself and PCSO HIRST have been to the area carry out foot patrols and deliver crime prevention material to the homes, followed by patrols when in the area.

I hope this has helped to reassure you that we are focused on addressing the concerns highlighted in Biggleswade and if you have any question or further information to help us in these areas please let us know
