Kate McFarland Update on HIF:

Now in the co-development phase working closely with Homes England to pull information together to submit a business case to Homes England in March 2019.

CBC are looking at Utilities, rail, road, i.e. junction improvements, and education, and are moving forward with these four items.

Kate will continue to keep us updated.

A15/11/ 9 & 11 <u>REVIEW OF CBC ON-STREET RESIDENTIAL PARKING SCHEME</u> 09 & 11 <u>& COMMUTER PARKING IN BIGGLESWADE</u>:

Mr C Proto and Ms C Farenden gave an update:

Improvements have now been made to the issues of parking enforcement in Biggleswade. Recruitment is underway urgently to replace 3 enforcement officers who have resigned.

The Parking Management Team will provide a three-monthly activity report to Mr McGregor.

People parking on double yellow lines in the evenings is causing a problem. Mr McGregor will pass on a list of problem areas and the Parking Enforcement Team may be able to look at these with the help of volunteers.

Mr Proto is happy to assist in the Task Group for Commuter Parking in Biggleswade.

BTC will be undertaking a review of the parking after 6 months. (January 2019)

BTC will need to address commuters parking dangerously. Need to work with Highways to get TRO's in place to enable enforcement. The Town Council is willing to look at co-funding for this.

15/11/10 10. <u>YELLOW LINES – VARIOUS SITES IN BIGGLESWADE:</u>

CBC confirmed that this work will be carried out next month.

15/11/12 12. <u>TOWN CENTRE DECLUTTERING</u>:

This work is still ongoing.
