b. Full House Theatre

Full House Theatre is an Ampthill based charity specialising in community arts projects for children and young people, and are working on a new dance performance project for children and family audiences. This is planned for delivery in Bedfordshire in September 2015 and they are looking to identify areas in Bedfordshire where we might be able to delivery this work.

Their aim is to make art accessible to all members of the community and they are asking Town Council funding the project for delivery in Biggleswade, perhaps in a village hall or even a library or other community space. The tour is already subsidised heavily by the Arts Council England and The Harpur Trust, and have other funding confirmed.

They are now seeking funding for community performances in Bedfordshire, which will cost £500 per performance, and any additional cost for using a space which they are hoping would be donated in kind.

They run a variety of different projects throughout the year including professional tours, Theatre in Education tours and other theatre projects. Full house has been working in Bedfordshire since 2001 and continues to deliver a large part of their work in Bedfordshire for the benefit of the local community. They work with local schools, community groups and local authorities to offer a range of exciting projects for the residents of Bedfordshire.

c. Venue for Muslims in Biggleswade

d. Appeal regarding site at 2 Wilsheres Road.

A planning application Ref No: CB/14/04907/FULL for the erection of a 3 bedroom dwelling at 2 Wilsheres Road went before council on 13th January 2015. Council resolved that there was no objections.

The application was refused by Central Bedfordshire Council on the 17th February 2015.

The applicant has now exercised his right of appeal against the decision of Central Bedfordshire Council.

e. Town Centre Benches

The following request has been received from Cllr F Foster re Town Centre Benches:

The wooden slats on most of the Town Centre benches in and around Market Square are in a bad state. A great deal of the varnish has peeled off making them not only an eyesore to residents and visitors alike but vulnerable to further weather damage. The Town Clerk has advised that the maintenance of the Town Square is the responsibility of CBC – a responsibility they are signally failing to live up to.

Members are asked to consider what action can be taken:

- (a) To rectify matters of the benches in the short term and
- (b) If it should be BTC policy to start a dialogue with CBC with a view to BTC taking back responsibility for the Town Square.

f. CBC proposal to introduce No Waiting and No Stopping - London Road, Biggleswade

The proposed Order is considered necessary for facilitating the passage of traffic on the road and for preserving or improving the amenity of the area through which the road runs. The restrictions are intended to address indiscriminate parking, particularly at the start and end of the school day. The proposed restrictions will ensure that the pedestrian access to Holmemead Middle School remains clear of parked vehicles during the school day and the bus stop is unobstructed.

g. <u>Mobile Catering Unit – Pegasus Way, Stratton Business Park</u>

Correspondence has been received from a resident who is considering setting up a mobile catering business and would like to trade from Stratton Business Park, where several businesses are located, and, from their research, there is no evidence of any mobile catering service.

Before CBC grant a licence, the Licencing Department consults with several bodies to ensure that there is agreement.

The applicant is asking if Town Council has any initial objections to a mobile catering unit being set up in Pegasus Way, trading Monday to Friday from approximately 06.30 – 15.00.
