#### A13/0803 3. TOWN MAYOR'S ANNOUNCEMENTS.

Cllr F Foster has attended the following events on behalf of Cllr Russell:

On Wednesday 7 August: I cut the ribbon at the opening of the new McDonalds Restaurant. I wished the franchisee and the staff well and welcomed the opening of the branch with the convenience of the 24-hour opening policy which will be of great benefit to shift workers and midnight feasters alike.

On Friday 9 August: I deputised for Cllr Russell at the 20<sup>th</sup> Birthday Celebrations of the Respite at Home Volunteers at Jordan's Mill. This can be anything from chatting to the patient while the main carer goes to get her hair done to taking the patient out to visit a garden centre. A great bunch of people who provide a wonderful service.

The Mayor reiterated the importance of supporting this important cause which is such a valuable service.

#### A13/0806 6. MEMBERS QUESTIONS

A13/0806.1 **a.** Cllr K Brown: Streetlights in Fairfield Road have been a long-standing problem. We now have lights, but they are still not working.

Cllr Bond has the latest update: three lights at the Sun Street site are now in operation. The reminder are new lights and will be in operation soon. Cllr Bond is monitoring this situation and will keep us informed.

Cllr K Brown: There are problems of parking outside the Cricket Club, reducing the road to one lane and making it exceptionally dangerous for the traffic. This has been noted by several members. It was agreed that it needs to be addressed and will be taken forward with CBC.

Cllr K Brown: BUFC have put up a gate which they are continually locking. This is on Council land and the Council have been made aware of this. Do we have an update?

Cllr Bond reported that this matter is being addressed by the BTC Works Manager.

Cllr M Knight: The BTC Parking Orders have been in place for one year now. Do we have the promised report from CBC?

Cllr M Russell replied that she is currently chasing this with both CBC Councillors and relevant Cabinet members and understands that it is currently being addressed. Cllr Russell will keep us informed.

Cllr L Fage: Regarding McDonalds Restaurant – what is their policy with regard to litter?

Cllr Ramsay attended a residents meeting with representatives from McDonalds where this topic was covered and reported that they were assured by McDonalds that an early morning "clear" would take place. However, in practice this was hampered by the fact that litter pickers are not allowed on public private property due to the trespass laws. McDonalds are currently addressing this with proposals to provide more litter bins in their area. They are keen to resolve this issue and will be closely monitoring the situation. We will be kept informed of the outcome.

Cllr Bond left the meeting during this discussion of this item.

Points made were:

- BTC does not need access for Town Council Business
- The map that been provided does not show the final position
- The Council would be upset at the closure of one particular footpath but cannot make any final decision until the full up to date information is available.
- Confirmation has been requested by 31 August. There is not sufficient time to consider this request as BTC needs to see the final information prior to making a decision.

It was **RESOLVED** that BTC will respond on the point regarding access to confirm that this is not required for Town Council Business.

It was **RESOLVED** that BTC request receipt of the correct information giving the final position before making an informed decision and to further request an extension of the time given to respond, as the 31<sup>st</sup> August is too short, given that the latest proposals have not been made available. There are also concerns over any divergence of the Green Wheel, and assurances that the future of the Green Wheel will not be affected are needed.

Cllr Bond re-joined the meeting

#### A13/0811.3 c. <u>Public Notice – Central Bedfordshire Council Proposes to</u> <u>Introduce an Experimental One-Way and Contra-Flow Cycle System</u> <u>in the Baulk, Biggleswade</u>

Concerns were expressed over this scheme. Members reported that the signage has already been put in place but is totally hidden by vegetation. It was felt that for additional safety it would be beneficial for a 20mph zone to be introduced in the Baulk for cars. An extension of

the 20mph zone in other areas would also be beneficial Other issues such as lack of parking enforcement on the double yellow lines at the junction are adding to the hazards in that area.

It was suggested that Head Teachers of the surrounding schools be given advance warnings of the changes as many pupil's cycle on that route.

It was noted that this system will commence on 16<sup>th</sup> August. Members fear that Highways have not full considered the implications of this scheme and will be closely monitoring the situation.

It was **RESOLVED** that the Town Clerk write an urgent letter to CBC voicing the concerns expressed by Members. Also to invite the CBC Highways Officer to a Council Meeting to give an explanation of the design, and the reasoning behind this Experimental system. This item to be brought to the next Biggleswade Joint Committee Meeting Agenda if necessary.

#### 7. ITEMS FOR CONSIDERATION

#### a. Off-Street Parking Permit Application

Cllr G Fage declared a pecuniary interest in this item and left the meeting for the discussion.

The wording on the application form has been brought to the attention of the Council by a concerned resident in Biggleswade. The wording causes concern for buyers in Rose Lane as to whether they will be able to get a parking permit with reference to point 4: *"No residents permits will be issued in respect of any property first occupied on or after 1<sup>st</sup> August 2018"* 

It was agreed that this wording is intended to cover "new build" rather than older and/or converted properties. However, it was felt that this requires clarification and should be discussed further.

Cllr Fage re-joined the meeting.

It was <u>**RESOLVED</u>** to refer the Terms & Conditions for Off-Street Parking to be reviewed by the Car Parks Working Group</u>

#### b. Taxi Rank for Biggleswade

Cllr G Fage and Simon Newton (TCOM) have been closely involved in discussions to provide a taxi rank for Biggleswade town. Simon has obtained suggestions for potential locations from the "Pubwatch" organisation meetings he has attended. The general consensus of Pubwatch being the bus station, which would become the Taxi Rank after the last bus service has left Biggleswade in the early evening.

It was agreed that a taxi service would be beneficial for the town and would improve the night-time economy for pubs and restaurants. Also, that a day-time service from the taxi rank would encourage daytime visitors and provide a much-needed service for local people to be able to get to doctors, dentists, shops and the general facilities of the town. Further, if was clarified that the proposed rank would be for Hackney Carriages only.

Members discussed several options for the siting of a taxi rank.

It was **RESOLVED** that the Century House/Bus Station site was the preferred location.

The views of BTC will be taken to the next BJC (Biggleswade Joint Committee) Agenda.

#### c. <u>A Boards</u>

The Draft Document was presented and received. Members welcomed the simplified policy.

The Town Centre is continually changing in terms of retailers. It was requested that regular checks on A Boards be carried out on a schedule of work.

Members requested that this item is brought forward to the next practicable Town Council Agenda once they have had the opportunity to fully read the document.

Council 27082019 Items for Consideration Item 10a NALC Request

Dear Rob.

I hope you are very well.

NALC wishes to co-organise three small themed study visits with Super Councils during the 2020-21 financial year. In 2019 the NALC study visit took place at Bishop's Stortford Town Council in Herts. and the theme was community transport for adult social care. It took the NALC Larger Councils' Committee and 12 paying delegates to learn about community transport for adult social care for two days in the town and feedback was very good.

The concept is to organize three smaller study visits in 2020-21 without the NALC LCC - with a ceiling of 12 paying delegates, two NALC officers and a sponsor. The visits will all have a different theme. The dates for the third study visit are slated to be 25-26 January 2021 to a council which has an excellent approach to strategic and corporate planning and as a NALC SCN council your council comes very high on the list in England. Also as a soon to-be SCN council it is highly likely that your council would have the resource and service / asset base to show paying delegates for the two days (between lunchtime on a Monday and lunchtime on a Tuesday). Your council will almost certainly also have the officer and member resource to co-organise the event with NALC in the run up to the event and over the two days of the event itself.

There is a mainline train station near to your council and a range of hotels which might suit. NALC would take the bookings for the event and there would be an administration fee (likely between £500 and £750 which we would pay to your council for allocating officer time at your end between now and September 2020 to co-organise the event). Worth saying there will be national coverage for your town council if the visit to your council proceeds.

The main requirements of the visit from the Town Council's perspective would be as below (and highlighted in the attached host council specification):

- Showcase relevant activities under the agreed theme for the visit;
- For a handling fee (amount to be agreed with a host council but likely between £500 and £750) recommend, liaise with and provisionally book a local hotel for a delegation of up to 15 people (paying delegate fees via NALC cover hotel bills);
- There will also be national coverage in the visit for the host council;
- Not be holding elections in 2020-21;
- Provide clerk / officer / member availability at a working evening meal on day 1;
- Ensure a room / council chamber availability for most of day two of the event;
- Deliver a Powerpoint presentation on the agreed theme at the start of day 2;
- Organise a three hour bus tour of services and assets related to the broad visit theme;
- Provide lunch at the council offices on day 2 after the bus tour (NALC to pay for); &
- Provide a room after the bus tour to jointly facilitate delegate discussion around the agreed visit theme before the end of the event.

As you will see from the above Bishop's Stortford link there is always excellent learning, sharing of good practice and promotional benefit to a host council from hosting the visit. NALC covers the administration for paying delegates – but we would need to liaise work very closely together **between now and January of 2021** on itineraries and local arrangements etc.

We are not approaching any other Super Councils to host this particular study visit as the two other study visits in 2020-21 will both have different themes.

Please confirm at this stage your council's in principle agreement to host the September 2020 study visit; also please confirm what services or assets delegates would have the chance to see and how the strategic planning theme would be visible over the two days by reply by 17:00 on 6/9 – thanks.

Notice is hereby given that Central Bedfordshire Council intend not less than seven days from the date of this Notice to make an Order the effect of which will be to prohibit any person proceeding on foot or on horseback or lead a horse or cycle along the length of Bridleway No 40, Biggleswade which extends from Ordnance Survey Grid Reference (OS GR) TL 1941, 4350 to OS GR TL 1941, 4350, the length of Bridleway No 53, Biggleswade which extends from Ordnance Survey Grid Reference (OS GR) TL 1941, 67 Bridleway No 53, Biggleswade which extends from Ordnance Survey Grid Reference (OS GR) TL 1941, 4350 to OS GR TL 1941, 4350, the length of Bridleway No 53, Biggleswade which extends from Ordnance Survey Grid Reference (OS GR) TL 1941, 4350 to OS GR TL 1941, 4350 to OS GR TL 1953, 4256 and the length of Bridleway No 52, Biggleswade which extends from Ordnance Survey Grid Reference (OS GR) TL 1953, 4256 to OS GR TL 1877, 4268.

This temporary closure is required for resurfacing works. The closure is expected to take place from 9<sup>th</sup> September 2019 and will end within six months of this date.

The alternative route for bridleway users while the closure is in operation will be Bridleway No 52, Biggleswade from where it meets Footpath No 40, and then following Bridleway No 54, Footpath No 18 and then using the footway on Langford Road, Biggleswade up to the A1. Further details, including a map, can also be found on the Council's website at: http://www.centralbedfordshire.gov.uk/leisure/countryside/rights-of-way/temporary.aspx The proposed Order will come into operation on 09 September 2019 for a period not exceeding six months or until the works which it is proposed to carry out on or near to the bridleways have been completed, whichever is the earlier. If the works are not completed within six months the Order may be extended for a longer period with the consent of the Secretary of State for Transport.



The Central Bedfordshire Council (the "Council") in exercise of its powers under sections 9 and 10 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers, hereby makes the following Order:

- 1. This Order shall come into operation on 16th day of August 2019 and may be cited as "Central Bedfordshire Council (The Baulk, Biggleswade)(One Way Traffic) Experimental Order 2019"
- 1. No person shall cause or permit any motor vehicle to proceed in the lengths of road specified in schedule 1 to this Order other than in the direction specified in that schedule for up to six months from the date the order comes into operation.
- 2. Nothing in Article 2 of this order shall apply to;
  - i. Mechanically powered vehicles or cycles;
  - ii. Motor vehicles being used for fire, police, and ambulance or Special Forces purposes engaged in operational work;
  - iii. A mechanical road cleansing vehicle;
  - iv. Any motor vehicle under direction or with the permission of a Police Constable in uniform;
  - v. Any motor vehicle being used in the service of the Local Authority or Water Authority in pursuance of statutory powers or duties;
- 3. The Council in exercise of its powers under the Local Authorities (Transport Charges) regulations 1998 (SI 1998 No. 948) and the Order may make a reasonable charge for any dispensation issued in contravention of any traffic regulation order contained in the order to cover the cost of administration.
