## a. Discussion on the short and long term plans for the further development of Fairfield Recreation ground facilities.

Cllr Mrs W Smith stated that in recent years the condition of the shared facilities had deteriorated and it had been agreed that Council would look to bringing Fairfield up to a better standard.

There is a need to improve facilities and the Cricket and Football Clubs have realised that the only long term solution is to work together and maximise grant potential. An outline plan for improving the area was circulated to members . Mr Jackson stated that a grant application to Sport England could provide up to 70% of the overall project.

Members felt they would wish to support the Clubs in improving Fairfield and it was agreed that Mr Jackson would submit a more detailed proposal for the first phase of a long term improvement plan for consideration by the Town Council.

It was also agreed that a capital sum for improvement of Fairfield be included in the 2008/2009 budget.

#### b. Problems being caused by a Sycamore tree at Sandy View

It was **RESOLVED** that the request for the tree to be cut down be granted subject to a suitable tree being planted in its place.
