7. BEDFORDSHIRE CONSTABULARY

PC Ian Wilson, Bedfordshire Police, reported that during May thefts from motor vehicles had reduced, although criminal damage had increased.

Brunel Drive and Berkeley Close had a problem with tyre slashing, but all was quiet now.

PC Wilson thanked Rob McGregor and his staff for their assistance in the dog at the aerial runway incident, and that as a result arrests had been made and fines issued.

There had been a recent shoplifting/theft, and with the help of a helicopter, 2 arrests had been made.

Speeding was still a problem in Shortmead Street and Hitchin Street and volunteers from the Community Safety Group were monitoring the situation with speed cameras.

The Highways dept were still negotiating with regards to the parking problems in Dells Lane.

Cllr Mrs W Smith stated that motorbikes were causing problems for residents in Ivel Gardens. PC Wilson replied that the Police were aware and keeping an eye on the situation.

a. <u>An introduction by Inspector Tania Coulling</u>

Inspector Tania Coulling introduced herself to Town Council. She is the new Inspector for Ampthill and Biggleswade and has been in the job 8-10 weeks. Previously Inspector Coulling spent 19 years as a Senior Officer at Northampton as well as serving in the Metropolitan Police based in Camden Borough.

She said she is looking forward to new challenges and encouraging team work and working together.

Inspector Coulling informed Members that the SNT capacity had been doubled for the Biggleswade area to support their commitment to improve Neighbourhood Policing.

Cllr George Wilson said that PC Ian Wilson had been on his own for some time, so the new posts would help his workload.

Cllr Wilson went on to ask as to why no Specials are operational in Biggleswade. Inspector Coulling replied that there is a strong team available and that 10 extra officers had been drafted in for the Biggleswade Carnival.

Cllr Tim Woodward said that he felt despondent about response times to emergency calls and felt that there were issues that the police needed to address.

Inspector Coulling replied that it depends on the nature of the incident and what information is relayed.

Cllr Mrs Sheila Grayston said that she had worked in North London, which is a slightly different concept with a minimal level of crimes, and at least Biggleswade had been assigned PCSO's.

Cllr Grayston praised the police for all their good work and felt that people do not appreciate all the hard work carried out by the Police.

11. **ITEMS FOR CONSIDERATION**

a. <u>School Travel Plan Improvement – St Andrews Lower School, Biggleswade</u>

Members considered correspondence received from Amey to inform Council that Bedfordshire Highways have investigated and propose an upgrade to the existing uncontrolled crossing point located on Sun Street, Biggleswade, between its junction with Fairfield Road and St Johns Street to a Zebra Crossing.

The main purpose of the scheme is to improve the existing route for pupils to get to/from St Andrews Lower School, Biggleswade. This proposal to upgrade the uncontrolled crossing point to a Zebra Crossing is considered as the best long term solution in the absence of a school crossing patrol operative which has recently been removed from this location.

Construction of this scheme will commence on the last week on July 2009 and will extend approximately for 4 weeks.

Members were invited to apply for further information or make any comments.

Cllr Mrs W Smith said she welcomed the proposal for a crossing. The last few years this had become a real problem area, especially since the removal of the crossing patrol.

b. East Beds Concert Band

Members considered correspondence from East Beds Concert Band thanking Council for the grant awarded to them as the Band relies of support from outside organisations in order to buy new music and for the purchase and maintenance of instruments.

In recognition of the support given to the Band by the Town Council they would like to invite Members to be guests at their Christmas Concert on Saturday 5 December. They ask that the date is noted but will be in contact again nearer the time.

It was **RESOLVED** that this be noted.

c. Vandalism at Biggleswade War Memorial

The Royal British Legion has contacted Town Council regarding vandalism at Biggleswade War Memorial. It has been brought to their attention by one of their Committee members that children are frequently being allowed to clamber over the War Memorial causing damage to the lettering on the flat stones at the side and have been seen picking out the lead of the names.

The letter also states that the War Memorials in Hitchin, Langford and Henlow are all protected by metal fencing and locked gates and asks why Biggleswade cannot do the same.

Whilst being fully aware that it is desirable to allow access the Memorial for those who wish to pay their respects, ask that a way be found to stop this vandalism even if restricting access is the only answer.

It was **<u>RESOLVED</u>** that this be noted and that a letter of thanks be sent to The Royal British Legion.

Mr McGregor will feedback to Council after he had attended the seminar regarding security and repairs of the War Memorial.

d. <u>Town and Country Planning Act 1990 – Section 247 proposed stopping up of highway(s) at land</u> off Church Street, Biggleswade

Department of Transport has written to Council informing of a draft order proposed under the provisions of the above Act and has included a map.

Members were asked to comment on the proposal before the end of the 28 day objection period specified in the public notice.

It was **<u>RESOLVED</u>** that Council raise no objection.

e. <u>Annual Bowls fixture – Town Council and Biggleswade Town Bowls Club</u>

Biggleswade Town Bowls Club has contacted Town Council with suggested dates for the Annual Bowls Fixture. The dates are: Thursdays, 23 July, 20 August or 13 August.

Town Council considered a request from Biggleswade Baptist Church to hold a picnic in Kitelands Park on Sunday 28 June at 4.30pm. This would take place of a regular tea that is normally held at the church, which normally has about 40 – 50 people attending.

12. ITEMS FOR INFORMATION

a. Introduction from new District Commander, Bedfordshire Police

Members received correspondence from Neil Wilson, the new District Commander for Central Bedfordshire, he will be based at Ampthill Police Station and also maintain an office at Dunstable. Over the past months the County Division has been restructured to ensure it is correctly aligned and meets the needs of the new partnership agreements arising from the newly created unitary authorities.

Inspector Tania Coulling has been appointed as the new Inspector for the Ampthill & Biggleswade area. Inspectors Berni White and Steve Barrett will remain at Dunstable and Leighton Buzzard respectively.

As part of the restructure two additional sergeant posts have been secured to support the commitment to improve Neighbourhood Policing. These Sergeants will be based in the Ampthill and Biggleswade area and will bring some support and supervision to the officers and PCSOs working the area. Negotiations are current taking place to co-locate the Safer Neighbourhood Team currently based at Ampthill to the Citizone Building, which will improve the Constabulary's visibility, accessibility and partnership working.

A substantial investment of resources has also been made in regards to CID. A new post has been created for Central Beds and DCI John Harwood has been appointed to lead the CID function across the district. Further to the CID Office based in Dunstable, further resources have been secured to enable establishment of a CID office in Ampthill. This office will be dedicated to the investigation of serious and priority crime within the former Mid Bedfordshire area.

Further to this, additional Sergeant posts have been created within the Prisoner Handing Unit based at Dunstable Police Station. This is to enhance the supervision of investigations, which in turn will speed up the criminal processes, increase the number offences brought to justice and reduce the time it takes to bring offenders to court.

It was **<u>RESOLVED</u>** that this be noted.

b. Introduction letter from new Area Inspector for Ampthill and Biggleswade

Correspondence has been received from Inspector Tania Coulling, the new Area Inspector for Ampthill and Biggleswade informing Council of the restructuring of the County Division.

As part of the restructure additional sergeant posts were established to support their commitment to improve Neighbourhood Policing. Details of these Sergeants are as listed:

Police Sergeant 778 Lisa Johnson covering Ampthill/Cranfield/Flitwick/Sheffford/Woburn area Safer Neighbourhood Teams.

It is planned to recruit a second Sergeant to assist with covering Ampthill area.

Police Sergeant 5289 Russell Glenister covering Biggleswade and Potton area Safer Neighbourhood Teams.

Police Sergeant 5309 James Shotbolt covering Sandy/Stotfold/Arlesey area Safer Neighbourhood Teams.

It was **<u>RESOLVED</u>** that this be noted.

c. Thank you letter from Biggleswade Rail Access Campaign

Members received correspondence from Biggleswade Rail Access Campaign thanking Council for their grant allocation which is to be put towards the cost of setting up a website. Such a facility will enable them to inform people of their meetings and the longer term aims of the group, which are to have lifts for all platforms to enable greater use of the rail service for both able bodied and disabled people.

d. <u>Thank you letter from the Pasque Charity</u>

Members received correspondence from the Pasque Charity thanking Council for their grant allocation which will be used in meeting the operating costs of Keech Cottage Children's Hospice. Less than 30% of Keech Cottage's budgeted running costs of £2.3m in 2009/10 are expected to be met from statutory sources. As a result, the income needed to continue providing vital support for the children and their families can only be found with the continued commitment of the community as a whole and through the voluntary gifts of the very many grant-giving, charitable trust, corporate and individual donors that recognise the significant value of the work carried out at Keech Cottage.
