- **b.** Members received and approved the **Recommendations** and **Resolutions** of the Public Lands and Open Spaces (PLOS) meeting held on 21 March 2017 at the Offices of Biggleswade Town Council, The Old Court House, Saffron Road, Biggleswade.

8. MATTERS ARISING

a. From the Minutes of the Town Council Meeting held on 14 March 2017:

Page 2, item B0206.1: Cllr B Briars asked if there had been an update on the traffic light situation in Rose Lane, as traffic is still not flowing correctly.

The Town Clerk has emailed a request to CBC and will chase up a response.

Page 3, item B0208.1: traffic parked on grass verges. The Town Clerk has emailed a request to CBC and will chase up a response.

Once the Town Clerk has received responses to the above, these items will be brought back to the Agenda.

Page 5, item B0210.1: Arrangements for furnishing the Orchard Community Hall: Cllr M Foster asked for an update. The Town Clerk reported that the hand-over has been delayed due to a dispute regarding payment of commuted sums. In the meantime, the staff has been working hard to ensure that we have quotations for items required, and that these will be ready for delivery as soon as we are in possession of the keys. There has been a concerted effort by all staff to get the hall up and running as soon as possible.

9. PLANNING APPLICATIONS

a. CB/17/01023/FULL - 115 London Road, Biggleswade

Demolition of existing building and structures. Erection of a one to two and half storey 70bedroom residential care home (Use Class C2) and associated access, parking and landscaping.

This item was taken in conjunction with item 11e of the Agenda.

It was **<u>RESOLVED</u>** to <u>**OBJECT**</u> to this application because there is likely to be insufficient parking to cater for the needs of staff, visitors and visiting health workers.

That the proposed access, egress is too close to the existing pedestrian crossing and a redesign of the scheme should be considered.

b. CB/17/01084/ADV – Unit K, A1 Retail Park, London Road, Biggleswade

Advertisement: Fascia sign on unit K together with No.2 vinyl applied to inside face of shop front glazing together with No. 4 to be located on the Landlord's Signage Towers fronting the main roads.

It was **<u>RESOLVED</u>** to raise **<u>NO OBJECTION</u>** to this application.

c. <u>CB/17/01165/FULL – Millennium House, 85 Shortmead Street, Biggleswade</u> Conversion of existing dwelling into 6 No. apartments.

It was **<u>RESOLVED</u>** to <u>**OBJECT**</u> to this application on the grounds of insufficient parking for the proposed scheme.

a. <u>Co-Option of Town Councillors</u>

Applicants will be informed of the Council decision, and a letter of invitation will be sent to Mr Fage and Patel, to attend the next Council Meeting on 11th April 2017.

b. Signposting of new footpaths in Biggleswade Town Centre

At the Town Centre Management (TCM) meeting of 21 February 2017, Members were asked to consider a request from Adam Maciejewski, Senior Definitive Map Officer, CBC, as to whether Biggleswade Town Council would wish every footpath to be signposted with green signs, or if we would consent to only key routes with destination signs being

At the TCM It was <u>**RESOLVED</u>** that only key routes are signed with destinations signs; that Adam Maciejewski suggest key routes to take back before Town Council, and that no works take place until a report has been received on the proposed decluttering of the Town Centre.</u>

Orders have now been made to add footpaths to the Definitive Map, subject to any objections received by CBC. A map of the Biggleswade Excluded Area is attached to this Agenda, which shows the routes and suggested signs for key routes.

It was **<u>RESOLVED</u>** that Members agreed the signage for key routes suggested by Adam Maciejewski.

c. <u>Request for Works to Trees subject to a Tree Preservation Order – CB/TRE/17/00094 –</u> <u>Biggleswade Baptist Church, 24 London Road, Biggleswade</u>

CBC has received an application to carry out Works to trees Protected by a Preservation Order: Lime trees (3 No.) to rear of site – reduce the trees to the same height as adjoining trees and as pollarded trees at the front of the site. Trees protected by TPO reference MB/TPO/01/00007 T8, T9 & T10.

This information was NOTED.

d. Housing Policy White Paper - Consultation

Members considered the attached NALC Policy Briefing which highlights relevant sections of the Government's recently published *Housing White Paper, together* with a template response form prepared by NALC.

Members would like to feed responses into the Consultation, and agreed that in view of the timescale, there was time to arrange a separate meeting to look at this, following which, collective responses can be made by the requested date of 28 April 2017.

e. Proposed Development of Mantle Site

Further to the Town Council Meeting of 14 March 2017, under Item B0210.2 b, several points of concern were a raised regarding a proposed redevelopment of land on the Mantle Site. Members are asked to consider pre-planning application concerns.

This item has been covered under 9a, where objections have been raised.

f. Proposed Development of Saxon Drive

Further to the Town Council Meeting of 14 March 2017, under Item B0210.2 b, several points of concern were a raised regarding a proposed redevelopment of land on Saxon Drive. Members were asked to consider pre-planning application concerns, and raised the following concerns and objections:

That Biggleswade Town Council raise strong **OBJECTIONS** on the following grounds:

- Strong objections to the development of that area
- It is the other side of a dangerous/fast road
- It is separate to the existing community
- Development will cause precedent
- Part of the site is a flood plain/subject to flooding
- Local Plan not in place, therefore this is premature
- Outside development envelope as it currently exists
- There may be a covenant
- Lack of infrastructure for the town to cope

- Mr Dilley: Regarding roads: The condition of the roads in Biggleswade is unacceptable, even where repairs to potholes have been made, these have re-appeared within weeks.
- Mr Bacon: I have watched so-called repairs taking place and have actually witnessed the workman treading in the tarmac with his feet. It is a total waste of time and money.
- Mr Bacon: Why don't the Council put out a notice to say that they are going to be drawing the yellow lines, and not simply draw round the parked vehicles? Also, regarding parking in Station Road, the sign is the wrong way!

Cllr Mrs M Russell commented that there doesn't seem to be any control over the contractors who undertake this work. She has spoken to Gary Baldwin on this point and understands that the implementation will not be complete until 18 April.
