# 1. APOLOGIES FOR ABSENCE

# 7. BIGGLESWADE MASTER PLAN

James Gleave gave the meeting an update and circulated a Biggleswade Transport Interchange Briefing Note.

Mr Lawrence asked that the grey slabs that delineate the road from the pavement in Hitchin Street be looked at, as these are cracking.

Mr Bowie will speak to the Stagecoach operator as coaches are regularly driving over the slabs.

# a) <u>Biggleswade Parking Strategy</u>

Cllr M Russell thanked Mr Bowie for the presentation made to Biggleswade Town Council.

Mr Bowie circulated a copy of the Biggleswade Car Parking Study. Information should be complete by July, and a Workshop will be held in September. Mr Bowie will keep the meeting updated.

# b) Aldi Car Parking

Solicitor's letters have been sent to Aldi requesting an alteration to signs in the car park. We are awaiting a response.

## c) Bonds Lane

Discussions are ongoing. Mr Bowie will keep the meeting updated.

#### 9. KITELANDS RECREATION GROUND GATE

#### 13. LONDON ROAD BUSINESS PARK

Cllr D Lawrence also raised concerns that fences are covering access to services. Sam Caldbeck will look into this.

## 14. STRATTON STREET RAILWAY BRIDGE

Amey engineers are working on a long term solution. Contact has been made with Network Rail and a meeting is scheduled for later this month. An Options Feasibility Plan will be developed in September. This will take into account the requirements of the Stakeholders, including Biggleswade Town Council. There is a two year lead time affecting the Railways, therefore it is not expected that any work will be done until 2015.

## 15. <u>SECTION 106 AGREEMENTS</u>

It was requested that the Section 106 Agreements Report on the Website be updated. The Chairman will look into this.
