Mr Rawlins has had a conversation with the CEO at M&S, following which the sign has been removed and the frame for this sign has been relocated to the side of their building facing the A1.

Cllr Mrs H Ramsay informed Mr Rawlins that the Council had objected to the placement of the illuminated sign at the back of the building, **and that she and other residents of Holme Court Avenue, considered the non-illuminated sign to be an eyesore.**

This application was granted by MBDC.

It was **RESOLVED** that Town Council raise **NO OBJECTION** to this Planning Application. However, the Town Council wishes to make clear that this consideration does not include play equipment that is referred to on drawing reference LAND 15/002-21.

# B0809.4 d. <u>CB/16/03478/FULL – 16 Wilsheres Road, Biggleswade</u>

Proposed bedroom extension.

It was **RESOLVED** that the Town Council raise **NO OBJECTION** to this Planning Application, provided the neighbours are consulted, and that any comments they may make are considered by CBC in their deliberations. In addition, the Council is to ensure that their guidelines on the size of the proposed extension to the principle dwelling are complied with in order to eliminate detriment in respect of light and privacy of adjacent residents.

# B0809.6 f. CB/16/03048/FULL - Warehouse, Bonds Lane, Biggleswade

Erection of 6 x 3 bedroom houses & 3 x 2 bedroom flats associated parking, cycle stores, bins and landscaping.

It was <u>RESOLVED</u> that the Town Council <u>OBJECT</u> to this Planning Application on the grounds of 1): Highway safety due to concerns regarding access and egress onto Bonds Lane and Palace Street, and 2): Parking, due to the development including accommodation for 24 residents and parking spaces for only 9 cars in a busy town centre location where parking is already an issue. It is understood that the provision for parking is below the CBC planning guidance regarding residential parking.

It was further **RESOLVED** that this application be **called in** to Development Management Committee, and this request has been made to Cllr T Woodward.

Although Cllr I Bond agreed with this view, he felt that the Council would be able to influence the process by taking part in the evaluation.

#### B0811.2 b. <u>Litter Bins – Biggleswade Market Square</u>

Although it was agreed that the litter bins are in a poor state of repair and do need replacement, Members did not agree to part fund on the grounds that the Market Square is the responsibility of CBC.

Members requested that the Minutes reflect the reasons for not wanting to fund the bins, due to money being spent on a mosaic scheme when other areas were a higher priority, including maintenance of Hitchin Street and Market.

# B0811.3 c. Work to trees in a Conservation Area: George Court, Station Road, Biggleswade.

CBC has received an application to carry out work at the above property. Felling and shortening of Hornbeam and Rowan trees overhanging parking bays and dropping leaves, sap, twigs, etc.
