b. MATTERS ARISING - Public Land and Open Spaces meeting held on 27 March 2012

a. <u>Item 5b – Installation of Parkour</u>

The Town Clerk advised Members that there is still one quotation outstanding.

<u>Item 5e - Biggleswade Cricket Club</u>

The floodlights still have not been removed.

Rob McGregor said that the Football Club that was supposed to take down the lights, was restricted with the hire of a crane. Rob McGregor had advised them of a local company who had quoted £1600 to take the lights down, the Football Club would make contact with this company.

Cllr Mrs W Smith said that if the contractor does not remove the floodlights within the next week, Town Council would remove them.

Item 6a - Land East of Saxon Drive, Biggleswade

CBC has replied to Town Council and they are not interested in Town Council purchasing the land. CBC has been contacted again and Town Council will keep chasing for a reply.

b) Grasmere Recreation Ground

Members received correspondence from Miss J Gunstone, regarding Grasmere Recreation Ground.

Members received a report from the Deputy Town Clerk summarising the issues with the provision of play equipment at Grasmere Recreation Ground.

It was **RECOMMENDED** that in the short term, the play equipment be fenced off and warning signs be erected. The play equipment is to be removed and possibly relocated. New equipment and location of replacements will be discussed at a later date.

c) <u>Jubilee Fun Day</u>

Members discussed the success of the Jubilee Fun Day held at Eagle Farm Road and to considered the possibility of organising an annual fun day

Members agreed that the Jubilee Fun Day had been a resounding success and thanked Town Council staff for all their hard work.

It was **<u>RECOMMENDED</u>** that the possibility of Town Council staging an annual Fun/Family day be discussed at full Council.

Members received the minutes of the meeting with BAG, held on 25th May 2012.

b) Soil Sample Kitelands

CBC planners have been provided with the findings of the soil sampling and asked to confirm that Town Council are able to proceed with installing the activity trail under Permitted Development rights.
